

E-CASH REGISTER SYSTEM







E-cash register is a new type of software-hardware complex equipped with a control mechanism device.



The collection, processing, storage, and prompt transmission of cash receipt data received and processed using the electronic cash register are ensured. Information about transactions carried out in the electronic cash register is transmitted in real time to the database of information systems of the State Tax Service.





Decision No. 52 of the Cabinet of Ministers of the Republic of Azerbaijan, dated February 14, 2019, on the approval of the 'Schedule for the Use of Cash Registers.'

The transition to e-cash registers has started in the Republic of Azerbaijan, consisting of four stages







SYSTEM OPERATIONAL DIAGRAM








E-CASH REGISTER SYSTEM STATISTICS







THE MAIN ADVANTAGES OF E-CASH REGISTER







The information about settlements during operations conducted through the e-cash register is transferred to the information systems database of the State Tax Service.



APPLICATION OF CRYPTOGRAPHY

Cryptographic algorithms are used during cash transactions and data transfer to the information systems database of the State Tax Service. These cryptographic procedures ensure the completeness and authentication of checks formed during cash transactions.



NEW CHECK FORMS

One of the main advantages of the new check forms is the QR code (and unique identifier) marked on it. Through it, customers, can remotely check whether that check is in the information systems database of the State Tax Service.



ANALYSIS AND CONTROL CAPABILITIES

Through the taxpayer's personal cabinet, it is possible to remotely obtain information about their daily turnover and volume of transactions. The tax authority has the opportunity to access taxpayers' information.


E-cash register monitoring system designed by the State Tax Service, is intended to oversee and manage electronic

cash registers (e-cash registers) used in businesses.

The possibility of obtaining information on digital receipts, e-cash registers, retail facilities, etc.

The possibility of obtaining information about risks and nonconformities using an alert system depends on various factors

The ability to remotely update device software (via the cloud) and remotely block cash register operation

The possibility of conducting examination (technical test) procedures for e-cash registers

The ability to obtain various types of statistical information
